ABOUT OUR GRANT PROGRAMS

The Foundation accepts grant applications from eligible 501(c)3 nonprofits and in limited situations, government agencies. Organizations must be in good standing with the IRS and should be located in or providing programs and services to residents of the Foundation's four-county service area:


- Milwaukee County
- Ozaukee County
- Washington County
- Waukesha County

The Foundation offers grants to support programs and projects which meet grant criteria and funding priorities. We also offer capital grants, grants to support medical research and other special funding opportunities. Please refer to our website for information on these special funding opportunities and their deadlines.

Generally, the Foundation awards grants to an organization for up to one year, although they may be longer, given program priorities. An organization may only have one open grant per grant period.

The Foundation is committed to promoting racial equity and inclusion in its own practices as well as the grantees receiving support through its competitive discretionary grant programs. The Foundation requires nonprofits to demonstrate board diversity by maintaining a governing board that is comprised of at least 10 percent people of color.*

The Foundation was created by and for the people of the greater Milwaukee area as a place where people from all backgrounds and interests come together to take action in the region and beyond – today and for generations to come. Through the generosity of our donors who earmarked resources to our Board's discretion, we are focusing the majority of discretionary grantmaking resources on four major issues facing our community: education, neighborhoods, economic opportunity and racial equity and inclusion. Grant dollars alone are not enough. The Foundation also will play a role of convener and work to unite diverse stakeholders and partners around these issues. This includes commissioning research and analysis of issues and disseminating the findings of that work. Our work in these areas also requires us to collaborate with nonprofits, other funders and the government. Through this work the Foundation will seek to inform policy and leverage grantmaking and other resources to promote outcomes important to our community.

GENERAL PROGRAM AREAS

Through our generous donors, the Foundation has created a permanent endowment for our region. This endowment provides resources to positively impact southeastern Wisconsin. From support for our wonderful arts and cultural assets to the preservation of the region's natural resources, the Foundation and our donors support a wide range of organizations and programs that contribute to a thriving community and enhance the quality of life for those living and working in the region.

Each year we award more than \$8 million in grants through donor resources left to the Board's discretion. The majority of our discretionary funds are invested in proven or promising organizations and work that aligns with the Foundation's strategies articulated in the Strategic Framework for Community Leadership. These funds support programs and projects across the following categories:



ARTS AND CULTURE

- Cultivate and support an appreciation of diverse cultures and art forms
- Deepen community-based arts education for children and adults
- Foster an appreciation of the rich heritage and diversity of our region
- Provide access to cultural experiences and programs that support academic achievement



COMMUNITY ECONOMIC DEVELOPMENT

- Support efforts to provide safe, affordable housing throughout the region
- Promote entrepreneurship and small business development to build a thriving regional economy
- Encourage sustainable development in communities which enhance the quality of life
- Support efforts to insure safe communities for all residents

BASIC STEPS TO APPLY

Grants are awarded through a competitive application process to projects that advance the goals of the impact areas or regional vitality.

- 1 Complete a profile for your organization on Philanthropy Online (POL)
- 2 Review our competitive grantmaking priorities and guidelines
- 3 Submit a letter of inquiry (LOI) on POL
- 4 If invited to submit a full proposal online, complete a grant evaluation plan
- 5 Staff will review proposal and meet with the applicant
- 6 Community Investment Committee will review the proposal and make a recommendation to the full Board, which has the final approval
- 7 Confirmation is sent to approved organizations

Organizations must have a current POL profile. For information on how to create or update a profile, please call the program and grants associate at 414-272-5805.

EVALUATION CRITERIA

Community Investment staff use the following criteria to review all proposals received:

- Demonstrated need for the project or program
- Fiscal health and stability of the organization
- Capacity of the organization to undertake the project
- Quality and effectiveness of the project
- Level of coordination and cooperation with other organizations
- Potential for leveraged funding, especially from national sources
- Project sustainability and opportunity for replication
- Racial/ethnic diversity of the organization's governing board of at least 10 percent
- Furthers Foundation's goals in the impact area or addresses regional vitality

WHAT THE FOUNDATION DOES NOT FUND

The Foundation will not fund through its discretionary grants:

- Individuals
- Individual schools
- Ongoing operating expenses
- Debt reduction or agency endowments
- Sectarian organizations for religious purposes
- For-profit organizations
- Partisan political activities
