Creating a personal legacy of giving

Including a charitable bequest in your estate plan is a simple way to make a lasting gift to your community. When you make this gift through the Greater Milwaukee Foundation, you establish a special fund that benefits the community forever and becomes your personal legacy of giving.

HOW IT WORKS

- You include the Foundation in your will as a bequest; we can help you or your attorney with recommended language.
- Upon your death, we set up a special fund in your name, in the name of your family, or in honor of any person or organization you choose.
- You determine the type of fund you would like to establish with your bequest gift.
- Your charitable gift is excluded from your assets for estate tax purposes.
- Our staff abides by your charitable wishes and makes grants to those organizations that reflect your wishes.
- We handle all the administrative details, including issuing grants to nonprofits in the name of the fund you establish. If you prefer, grants can be made anonymously.
- Your gift can be placed into a fund that is invested over time. Your gift and all future earnings from your gift—will be a permanent source of community capital, helping to do good work forever.

With the help of her professional adviser, Irene revised her will to include an inheritance for the Hoover's college-age niece, with the remainder creating the Hoover Bakery Fund, a field of interest fund designed to support community development efforts. Because it will be endowed, her gift will provide a growing source of community funding for festivals, neighborhood revitalization, publicly accessible artwork, and other community improvements. "I like knowing that when I'm gone, our legacy will be one of helping others strengthen our community," says Irene.

Making a bequest to the Foundation is an easy way to transfer assets to charity. And, you can decide to do it at any age by adding to an existing will or drafting a new one. In doing so, you leave a legacy to your community, while enjoying the assets you need to maintain your current lifestyle. Plus, you are able to distribute some or all of your assets, tax free.

You can give cash, appreciated stocks, or other assets. Some of the most taxefficient asset types to give through your estate plan come from retirement plan accounts, since heirs would be taxed on the income. Through your will, you can choose to give a stated dollar amount, a specific property, a percentage of your estate, the remainder after distributions to other beneficiaries, or you can make your gift contingent on certain events.
